


2021 CJK Cooperation Dialogue Speakers' Biography

Masakazu Toyoda

Chairman and CEO, Japan Economic Foundation (JEF)

Masakazu Toyoda is Chairman and CEO of the Japan Economic Foundation.

He also serves as Special Advisor to the Institute of Energy Economics (IES, where he was previously Chairman and CEO), Adjunct Professor with the National Graduate Institute for Policy Studies (GRIPS) and is on the Board of Directors for the Pacific International Center for High Technology Research (PICHTR). In 2008, he was Secretary-General of the Secretariat of Strategic Headquarters for Space Policy with Japan's Cabinet Secretariat, and from 2008-08 he was Vice-Minister for International Affairs for Japan's Ministry of Economy, Trade and Industry (previously the Ministry of International Trade and Industry), where he has also held several other positions.



Naoyuki HARAOKA

Executive Managing Director, Japan Economic Foundation (JEF)

Mr. Naoyuki Haraoka has been Executive Managing Director of the Japan Economic Foundation (JEF) since 2007. After graduating the University of Tokyo in 1978 (Bachelor of Economics), he joined MITI (Ministry of International Trade and Industry) of Japanese government. Having been posted in the industrial policy section and the international trade policy section for a few years, he was enrolled in a two year MPA (Master of Public Administration) programme at Woodrow Wilson School of Princeton University in the US on a Japanese government sponsorship. After having acquired MPA at Princeton, he rejoined MITI in 1984 as an economist. Since then he had been posted as Deputy Director and Director of a number of MITI divisions including Research Division of International Trade Policy Bureau. He was also posted in Paris twice, firstly, Principal Economist of Trade Bureau of OECD (Organization of Economic Cooperation and Development) from 1988 to 92 and secondly Counselor to Japanese Delegation of OECD from 1996 to 99. After coming back to MITI from his second stay in Paris, at the occasion of the government structural reform in 2001 when MITI was remodeled as METI (Ministry of Economy Trade and Industry) he joined the efforts to found METI research institute, Research Institute of Economy Trade and Industry as its Director of Administration. He became Chief Executive Director of JETRO San Francisco in 2003 and stayed in San Francisco until 2006. He was Director-General of METI Training Institute from 2006 until July, 2007 when he left METI permanently.



Yukiko FUKAGAWA

**Dean and Professor, School of Political Science and Economics,
Waseda University**

Yukiko Fukagawa is currently the Deputy Dean and Professor, School of Political Science and Economics, Waseda University. After undergraduate program at Waseda, she studied at Yale University for MA in International Development Economics, and finished Ph.D program at Waseda Graduate School of Business Studies. Her major interest lies in economic development in East Asia, especially Korea. She worked for Japan External Trade Organization (JETRO) and Long-Term Credit Bank Research Institute (LTCBR) before joining the faculty member of Aoyama Gakuin University and the University of Tokyo. She came back to Waseda in 2006. She was a visiting fellow at Cambridge University in 2014, and Yonsei University in 2015.

She engaged in many consultation and advisory activities for the government, such as the Committee for Industrial Structure in the Ministry of Economy and Industry etc.. Her recent publication includes “Beyond “Abenomics”: Japan’s integration catch-up and prospects for Japan-UK cooperation”, Chatham House, 2019, Economic Development in East Asia, co-ed with Fumiyasu Mieno, Minerva publication, 2017, Japan’s Future International Cooperation, Nihon Hyoronsha, 2015.



Shujiro URATA

Professor Emeritus, Waseda University.

Shujiro Urata is Professor Emeritus, Waseda University. He was Professor of International Economics, Graduate School Asia-Pacific Studies, Waseda University. He is currently Faculty Fellow at the Research Institute of Economy, Trade and Industry (RIETI), Specially Appointed Fellow at the Japanese Centre for Economic Research (JCER), Senior Research Advisor, Economic Research Institute for ASEAN and East Asia (ERIA), Visiting Fellow, Asian Development Bank Institute (ADBI) and Distinguished Senior Fellow at the Institute of Developing Economies (IDE-JETRO). Professor Urata received his BA in Economics from Keio University, MA and Ph.D. in Economics from Stanford University. He is a former Research Associate at the Brookings Institution, an Economist at the World Bank. He specializes in International Economics and Economics of Development. He has held a number of research and advisory positions including senior advisor to the Government of Indonesia, consultant to the World Bank, OECD, the Asian Development Bank and the Government of Japan. He has published a number of books and articles on international economic issues. His recent books include *Achieving Inclusive Growth in the Asia Pacific*, co-editor, Australian National University Press, 2020, *Enhancing SME Participation in Global Value Chains*, editor, Asian Development Bank Institute, 2021, *The Effect of Globalisation on Firm and Labour Performance*, co-editor, Routledge, 2021, and *Globalization and Its Economic Consequences: Looking at APEC Economies*, co-editor. Keigo Akimoto

**Group Leader of Systems Analysis Group, Chief Researcher,
Research Institute of Innovative Technology for the Earth (RITE)**

Keigo Akimoto was born in 1970. He received Ph.D. degree from Yokohama National University in 1999. He joined Research Institute of Innovative Technology for the Earth (RITE) to work with the Systems Analysis Group in 1999, was a senior researcher in 2003 and the Leader of the Systems Analysis Group and an associate chief researcher at RITE in 2007. Currently he is the Leader of the Group and a chief researcher at RITE. He was a guest researcher at IIASA in 2006, a guest professor, Graduate School of Arts and Sciences, the University of Tokyo between FY2010 and 2014, and a Lead Author for the Fifth and Sixth Assessment Report of IPCC. He is a member for several advisory bodies on energy and environmental policy for Japanese government including Strategic policy committee, Advisory committee for natural resources and energy; and Global environment subcommittee, Industrial structure council; Climate change impact assessment subcommittee, Central environment council; Calculation Committee for Procurement Price for renewable energies. His scientific interests are in modeling and analysis of energy and environment systems. He received the Peccei Scholarship from IIASA in 1997.



Izuru KOBAYASHI

Deputy Commissioner for International Affairs, Agency for Natural Resources and Energy (ANRE) Ministry of Economy, Trade and Industry (METI)

Mr. KOBAYASHI was appointed to the current role in October 2021. He has rich experience in international cooperation, particularly in Southeast Asia, and in innovation policy. Before assuming the current position, he served as an Executive Director of New Energy and Industrial Technology Development Organization (NEDO), where he was in charge of managing NEDO's international operations as well as overseeing its key domestic R&D programs such as hydrogen based steel production, power generation by ammonia as a fuel, and CCS. He also spent four years in Jakarta (2015-2019) as a COO of Economic Research Institute for ASEAN and East Asia and four years in Bangkok (2005-2009) as a Chief Representative of Japan Overseas Development Corporation, where he deeply engaged with ASEAN Secretariat and various ASEAN and ASEAN-plus Ministerial frameworks to support their cooperation activities.

Mr. Kobayashi joined METI in 1993 and held various positions including Director of Business Environment Enhancement Division and Director for Climate Change Negotiation. He also spent two years in Economic Planning Agency where he led the team in charge of analyzing activities of Japan's manufacturing industries.

He earned Bachelor of Law from University of Tokyo in 1993 and MBA in 2002 from Yale School of Management.



Naoko DOI, Ph.D.

Group Manager/Senior Economist

The Institute of Energy Economics, Japan (IEEJ)

Dr. Naoko Doi, a Japanese national, is currently serving as the group manager of the Energy Efficiency Group, Climate Change and Energy Efficiency Unit, the Institute of Energy Economics Japan. She had received a Ph.D. degree from Kyoto University in Global Environmental Studies. And, she had received a master's degree in Applied Economics from Doshisha University.

Her research areas include (1) energy modelling, (2) energy savings and potential analysis, (3) global energy efficiency policy analysis, and (4) energy project evaluation. As the project leader she has authored a number of research reports on these areas, including the studies commissioned by Asian Development Bank (ADB), Asia Pacific Energy Research Centre (APEREC), Economic Research Institute of Asia (ERIA), Japan International Cooperation Agency (JICA), and Ministry of Economy, Trade and Industry (METI).

Dr. Doi specializes in energy efficiency and conservation analysis with the focus on the residential, commercial and transport sectors. She has published reports and articles in those areas. Since 2013 up to now, she has been leading a research project on the analysis of the residential/commercial sectors with the focus on energy savings potential analysis, policies and practices for zero energy buildings, and smart community development in Japan. She has published reports and papers on urban transport energy savings potential, and electrifying transport systems in the emerging economies.

Naoyuki Yoshino: Professor Emeritus of Keio University in Tokyo Japan, Visiting Professor at GRIPS and Director of Financial Research Center (FSA Institute, Government of Japan). Ph.D from Johns Hopkins University (where his thesis supervisor was Sir Alan Walters (UK Prime Minister Margaret Thatcher's Economic Adviser)). Assistant Professor of State University of New York, Visiting scholar at MIT (USA), Visiting Scholar at the Central Bank of Japan, Visiting Professor at the Univ. of New South Wales (Australia), Fondation Nationale des Sciences Politiques (France). He received Honorary Doctorates from Univ. of Gothenburg (Sweden) and Martin Luther University of Halle-Wittenberg (Germany). He was conferred Fukuzawa award from Keio University for his contribution to research. He was chairing Financial System Council under Prime Minister and Foreign exchange council under Finance Minister of Japan. He is currently chairing Financial education council under the Central Bank of Japan and Financial Services Agency, Government of Japan. He was the Dean/CEO of Asian Development Bank Institute (ADBI) in Tokyo (2014-2020).



TANAKA Kazushige

**Deputy Director-General,
Commerce and Service Industry Policy Group , Ministry of Economy,
Trade and Industry (METI)**

Mr. TANAKA joined MITI (Ministry of International Trade and Industry) of the Japanese government in 1994. Since then he has engaged in several industrial and international policy sections such as energy and trade policy planning. He was also posted in Paris as a Counselor, Permanent Delegation of Japan to the OECD/IEA. After coming back to METI, he was appointed as a director of international energy policy division and a representative of Japan to the IEA. In 2019, He organized G20 Ministerial Meeting on Energy Transitions and Global Environment for Sustainable Growth in Japan. Since 2020, he has worked for commerce and service industry policy group which covers healthcare industries.

Mr. TANAKA received the Bachelor of Laws (University of Tokyo) and Master of Philosophy of Development Studies (IDS (Institute of Development Studies), University of Sussex). He was a Yale World Fellow in 2005 (Yale University).

Mr. Hu has contributed a lot to the development of China's diplomacy.

Vice President, Chinese People's Institute of Foreign Affairs

Amb. Ou Boqian graduated from the China Foreign Affairs University (CFAU), and got the Master of International Policy and Practice (MIPP) from the George Washington University of USA. She joined the Ministry of Foreign Affairs (MFA) in 1989 and worked on China-Africa relations for 10 years. From 2000 to 2001, she served as Deputy Secretary of the CPC Committee of Xincheng District, Xi'an Municipality, Shaanxi Province. From 2001 to 2004, she worked as Counselor of the Information Department, MFA. From 2004 to 2007, she was Political Counselor of the Chinese Embassy in Australia. From 2007 to 2013, she served as Counselor of the Policy Planning Department and then Deputy Director-General of the General Office, MFA. She was Ambassador Extraordinary and Plenipotentiary of China to Grenada from 2013 to 2017. She assumed her current post as Vice President of CPIFA in 2017.

He is distinguished professor at universities including Chinese Academy of Governance, Peking University, Northeastern University and some others.



He served as a member of EAVG, China-ASEAN Cooperation Official Expert Group, Task Force of ASEM and Chairman of Joint Expert Group for Feasibility Study on EAFTA, and a Member of Joint Expert Group for Feasibility on CEPEA.

Jiang Ruiping, He has received bachelor's, Master's and doctor's degrees in economics. 1982-1985 Taught in the Department of Economics, Hebei University, 1988-1997, he served as the deputy director of the Institute of Japan Studies, Hebei University. Concurrently serving as a researcher of the Pilot Free Trade Zone Construction Research Center of the Counsellors' Office of the State Council, a member of the Expert Advisory Committee for the Construction of Hainan Free Trade Port, Honorary Dean of Hainan Institute of Open Economic System, a member of Policy Advisory Committee of the Ministry of Foreign Affairs, Ministry of Commerce, Ministry of Industry and Information Technology, China Council for the Promotion of International Trade and other ministries. On February 23, 2009, served as a lecturer of the 12th collective study of the 17th Politburo of the Central Committee of the "World Economic Situation and Promoting the Sound and Rapid Development of China's Economy".



QIU Guohong

Former Chinese ambassador to South Korea

After graduating from Shanghai International Studies University, I was assigned to the Ministry of Foreign Affairs of the People's Republic of China. In 1991, I served as the Second Secretary and First Secretary of the Chinese Embassy in Japan, before serving as the First Secretary, Deputy Director and Director of the Ministry of Foreign Affairs. In 1998 I was appointed the Counselor of the Chinese Embassy in Japan before being promoted to become the minister. In 2006, I served as deputy director of the Department of Asian Affairs of the Ministry of Foreign Affairs. Later I was appointed Chinese Plenipotentiary Ambassador to Nepal from 2008 to 2011, before taking the role of Director of Security Affairs of the Ministry of Foreign Affairs from 2011 to 2014. Since then, I have been the Chinese Ambassador to South Korea. And most recently since June 2020, I have also become the Chief Research Fellow of Northeast Asian Affairs at the Charhar Institute.



WU Shicun

President, National Institute for South China Sea Studies

Wu Shicun has a PhD in history and is president and senior research fellow of China's National Institute for South China Sea Studies. He also serves as chairman of board of directors of the China-Southeast Asia Research Center on the South China Sea, chairman of the advisory board of Institute for China-America Studies, vice president of the China Institute for Free Trade Ports Studies, deputy director of the Collaborative Innovation Center of South China Sea Studies, Nanjing University, and adjunct professor of Nanjing University and Shanghai Jiao Tong University.

Dr Wu's research interests cover the history and geography of the South China Sea, maritime delimitation, maritime economy, international relations and regional security strategy. His recent books include: *Hainan Free Trade Port: A Global Perspective* (Guangdong People's Publishing House, 2021), *The 21st Century Maritime Silk Road: Challenges and Opportunities for Asia and Europe* (Routledge, 2019), *South China Sea Law fare: Post-Arbitration Policy Options and Future Prospects* (South China Sea Think Tank / Taiwan Center for Security Studies, 2017), *Arbitration Concerning the South China Sea: Philippines versus China* (Ashgate, 2016), *UN Convention on the Law of the Sea and the South China Sea* (Ashgate, 2015), *Non-Traditional Security Issues and the South China Sea-Shaping a New Framework for Cooperation* (Ashgate, 2014), *Recent Developments in the South China Sea Dispute: The Prospect of a Joint Development Regime* (Routledge, 2014), *Solving Disputes for Regional Cooperation and Development in the South China Sea: A Chinese perspective* (Chandos Publishing, 2013). Dr Wu has published widely in academic journals and been the subject of frequent media interviews as a senior commentator on South China Sea, regional security issues, the Belt & Road Initiative and the development of Hainan Free Trade Port.



BAI Xiaohong

Vice President, Shanghai National Accounting Institute

She graduated from Research Institute for Fiscal Science, Ministry of Finance, majoring in accounting. 2000 to 2020 she held various positions including: deputy director of Legal Department, the Chinese Institute of Certified Public Accountants, director of Research and Development Department, director of Professional Development Department. She is a part-time supervisor of the Juris Master Program in Peking University and China University of Political Science and Law.



TIAN Xueyuan

Academician of Chinese Academy of Social Sciences

Tian was graduated from the department of economy at Peking University in 1964. He has been Guest Researcher at the East-West Center from 1982 to 1983, and been the director of the Institute of Population and Labor Economics at the Chinese Academy of Social Sciences from 1984 to 1998. And he is also a member of the Expert Advisory Committee of national social sciences research.

Professor Tian has published more than 500 journal articles and 12 books. Among which, three of his books have been translated into other languages such as English, Japanese, and Russian. He has conducted innovative research in quite a few areas such as population development strategy, cost-benefit study of children to a society, population and sustainable development, and so on. He has been honored among the first as the national “Young Expert with Outstanding Contributions”, and he has also been awarded the first prize of National Science and Technology for technological achievement, the Chinese Population Award (top prize in Chinese population studies), National Book Award, International Intellectual Celebrity (awarded by the IBC in UK), and the World’s Five Thousand Celebrity (titled by the ABI in the US).




ZHOU Weisheng

Ph.D. (Kyoto University), Professor of College of Policy Science of Ritsumeikan University

Director of Research Institute of Global 3E, majored in energy systems engineering, environmental policy, population policy, policy engineering and sustainability science.

He has served as the chief researcher and research consultant of Research Institute of Innovative Technology for the Earth (RITE), a special professor of Osaka University, the director of Ritsumeikan University Research Center for Sustainability Science (RCS), and the secret director of Belt and Road Initiative Japan Research Center (BRIJC). His books include "Earth Regeneration Plan-CO2 Reduction Strategy", "Sustianability Science", "Contemporary Policy Science", "East Asian Low-Carbon Community" and so on.



KIM Sung-Hwan

Chairman of the East Asia Foundation

Former Minister of Foreign Affairs and Trade of the R.O.K

Sung-Hwan Kim was a career diplomat and served as the Minister of Foreign Affairs and Trade of the Republic of Korea from October 2010 to March 2013. With a career spanning over 36 years, he held a number of senior diplomatic posts including the Senior Secretary to the President for Foreign Affairs and National Security and Vice Minister of MOFAT. He was ROK's ambassador to Austria and Permanent Representative to the International Organizations in Vienna and the ROK's Ambassador to Uzbekistan. He was appointed as a Member of the UN Secretary-General's High-Level Panel of Eminent Persons on the Post-2015 Development Agenda in July, 2010. After retiring from the Foreign Service, he served as the Chair of Institute for Global Social Responsibility and Distinguished Visiting Professor at the Seoul National University until March 2015. He also taught at Hanyang University as a Distinguished Professor and served as the Chairman of the Gangwon Art and Culture Foundation. He is now working as the Chairman of the East Asia Foundation and the Chairman of the Beautiful Mind Charity Foundation.



AHN Choong Yong

Distinguished Professor, Chung-Ang University

Dr. Choong Yong Ahn is currently Distinguished Professor at the Graduate School of International Studies, Chung-Ang University Seoul. He is also Co-Chair of the Korea-India Strategic Dialogue organized by the Seoul International Forum. Previously, he was Chairman, Korea Commission for Corporate Partnership (KCCP: 2014-2018) to induce voluntary collaborations between Korea's big businesses and SMEs, and also Chairman of the Board, Korea Electric Power Corporation. Before taking the KCCP post, he served as presidentially appointed Foreign Investment Ombudsman (2006-2014) for foreign direct investors in Korea. He is also former Chairman of the Presidential Regulatory Reform Committee (2010-2012). While on sabbatical from Chung-Ang University, he also served several posts such as the President of the Korea Institute for International Economic Policy (2002-2005); Chair of the APEC Economic Committee(2002-2005); Chair of Board, Choheung Bank; consultant to the World Bank; UNIDO Chief Technical Advisor to the Economic Planning Unit of Malaysia to design Malaysia's industrial master plan; and served as President of several academic societies in Korea including the Korea International Economics Association, Korean Association of Trade and Industry Studies, and the Korea Econometric Society. He was also a visiting professor to Economic Research Institute, Kyoto University, Japan. Dr. Ahn's honors include the Economist of the Year Award from the Maeil Business Daily Newspaper in Korea, the Okita Policy Research Award by the National Institute for Research Advancement in Japan for his publication on "*Modern East Asian Economy*," and Free Economy Publication Award by the Federation of Korean Industries. Since receiving his Ph.D. from Ohio State University, Dr. Ahn has published many articles in international journals including *Review of Economics and Statistics*, *European Economic Review*, *Japanese Economic Review*, *Journal of Asian Economics*, *Global Asia*, and Monograph papers in North-Holland, Cambridge University Press, Springer, Edward Elgar, Palgrave Macmillan, Iwanami Shoten of Japan, Peking University Press, etc.

KIM Do Hoon

Professor, Sogang University

former President, Korea Institute for Economics and Technology

KIM, DoHoon teaches “Korea’s Economic Development” and “international Business Strategy focused on Global Value Chain in East Asia” at GSIS (Graduate School of International Studies), Sogang University. He was former president of the Korea Institute for Industrial Economics and Trade (KIET) from May 2013 to May 2016. Before being appointed as president of KIET, he worked as director of several research divisions in KIET, such as division of industrial policy and division of industrial cooperation and globalization and served as vice president for research, spanning the years from 1979 through May 2013. He was detached from KIET to work for the OECD in Paris as principal administrator at the trade directorate from September 1997 to September 1999. He worked for IERI at University of Washington as a visiting scholar. He served as president of a couple of Korea’s academic associations including KSRS (Korea Society of Regulatory Studies). He has been also members for many government policy advisory committees such as commission for corporate partnership, and advisory council for budget policy.
