Dr. John Hamre, CSIS President and CEO

John Hamre was elected president and CEO of CSIS in January 2000. Before joining CSIS, he served as the 26th U.S. deputy secretary of defense. Prior to holding that post, he was the Under Secretary of Defense (comptroller) from 1993 to 1997. As comptroller, Dr. Hamre was the principal assistant to the Secretary of Defense for the preparation, presentation, and execution of the defense budget and management improvement programs. In 2007, Secretary of Defense Robert Gates appointed Dr. Hamre to serve as chairman of the Defense Policy Board, and he served in that capacity for four secretaries of defense.

Mr. Masakazu Toyoda, JEF Chairman and CEO

He currently serves as Chairman and CEO of the Japan Economic Foundation (JEF), as well as Special Advisor to the Institute of Energy Economics of Japan; an Adjunct Professor at Japan's National Graduate Institute for Policy Studies (GRIPS); and Director of the Pacific International Center for High Technology Research. He is the former Chairman and CEO of the Institute of Energy Economics (2010-2021); served also for nearly a decade on both the Board of Governors of the Oxford Institute of Energy Studies (2012-2021); and the International Advisory Board Council of the King Abdullah Petroleum Studies and Research Center (KAPSARC) in Saudi Arabia (2011-2019). During his distinguished government career, he served in numerous key positions within the Ministry of Economy, Trade, and Industry of Japan culminating in his service as Vice Minister for International Affairs (2007-2008). He also subsequently served as Secretary General of the Secretariat for Space Policy in Japan's Cabinet Secretariat. Mr. Toyoda holds a Master of Public Affairs degree from the Woodrow Wilson School of Public and International Affairs at Princeton University (1979), and an undergraduate Bachelor of Law degree from the University of Tokyo (1973).

Ms. Erin Murphy Senior Fellow and Deputy Director, Economics Program, CSIS

Erin Murphy is a deputy director and senior fellow for the Economics Program at the Center for Strategic and International Studies (CSIS). She has spent her career in several public and private sector roles, including as an analyst on Asian political and foreign policy issues at the Central Intelligence Agency, director for the Indo-Pacific at the U.S. International Development Finance Corporation, founder and principal of her boutique advisory firm focused on Myanmar, and an English teacher with the Japan Exchange and Teaching (JET) Program in Saga, Japan. Murphy received her master's degree in Japan studies and international economics from the Johns Hopkins School of Advanced International Studies and her bachelor's degree in international relations and Spanish from Tufts University. She was also a 2017–2018 Hitachi international affairs fellow in Japan with the Council on Foreign Relations. Murphy is also the author of *Burmese Haze: US Policy and Myanmar's Opening-and Closing* (Association for Asian Studies, 2022).

Mr. Bonji Ohara, Senior Fellow, The Sasakawa Peace Foundation

Mr. Bonji Ohara graduated from the National Defense Academy of Japan in 1985 and completed a master's program and got the master's degree of Area Study at the University of Tsukuba in 1998. He is a security expert studying Contemporary Chinese Politics, Chinese Security/Defense Policy, US- China relations, Japan-US Alliance, Japanese Security Policy. Mr. Ohara succeeded in the armed force before joining NIDS in 2010, then IHS Jane's in 2011, and then the Tokyo Foundation as a Director of Research before assuming the position of Senior Fellow in the Sasakawa Peace Foundation in June 2017.

Mr. Gerard DiPippo, Senior Fellow, CSIS

Gerard DiPippo is a senior fellow with the Economics Program at the Center for Strategic and International Studies (CSIS). He joined CSIS after nearly 11 years in the U.S. intelligence community (IC). From 2018 to 2021, DiPippo was a deputy national intelligence officer for economic issues at the National Intelligence Council, where he led the IC's economic analysis of East Asia. He also was a senior economic analyst at the CIA, focused on South and East Asia, and global economic issues. DiPippo holds a bachelor's degree in economics and philosophy from Dartmouth College.

Dr. Kori Schake, Director of Foreign and Defense Policy Studies, American Enterprise Institute

Kori Schake is a senior fellow and the director of foreign and defense policy studies at the American Enterprise Institute (AEI). Before joining AEI, Dr. Schake was the deputy director-general of the International Institute for Strategic Studies in London. She has had a distinguished career in government, working at the US State Department, the US Department of Defense, and the National Security Council at the White House. She has also taught at a number of world-class institutions. Dr. Schake is the author of five books. Dr. Schake has been widely published in policy journals and the popular press. Dr. Schake has a PhD and MA in government and politics from the University of Maryland, as well as an MPM from the University of Maryland School of Public Policy. Her BA in international relations is from Stanford University.

Since 2015, he has been a Visiting Professor at the Hitotsubashi University School of International and Public Policy.

Mr. Matthew Goodman, Senior Vice President and Simon Chair in Political Economy, CSIS

Matthew P. Goodman is senior vice president for economics and holds the Simon Chair in Political Economy at CSIS. The CSIS Economics Program, which he directs, focuses on international economic policy and global economic governance. Before joining CSIS in 2012, Goodman served as director for international economics on the National Security Council staff, helping the president prepare for global and regional summits, including the G20, Asia-Pacific Economic Cooperation (APEC), and East Asia Summit. Goodman holds an M.A. in international relations from the Johns Hopkins School of Advanced International Studies (SAIS) and a B.Sc. in economics from the London School of Economics and Political Science (LSE).

Dr. Mary Lovely, Anthony M. Solomon Senior Fellow, Peterson Institute for International Economics

Mary E. Lovely is the Anthony M. Solomon Senior Fellow at the Peterson Institute. She is also the Library of Congress Chair in US-China Relations with the Kluge Center at the Library of Congress. Lovely is professor emerita of economics at Syracuse University's Maxwell School of Citizenship and Public Affairs, where she was Melvin A. Eggers Economics Faculty Scholar from 2010 to April 2022. She was coeditor of the China Economic Review during 2011–15.
