In the years since, the world has undergone significant changes. The war in Ukraine with Russia's invasion occurred then shows no sign of resolution. Geopolitical risks have risen, along with surging energy and food prices. The number of migrants continued to grow which made political landscapes shift rightward in many regions. We have also seen increased volatility in global financial markets that widened social gaps and economic inequality.

Meanwhile, generative AI has become widely integrated into both our society and industry, transforming the emerging technology into a new normal. In the US, President Trump has been re-elected, bringing with him a wave of new protectionist policies. The so-called "Trump tariffs" remain unresolved, contributing to continued disruptions in global trade and economic stability.
