

Global Governance at a Crossroads - a Roadmap Towards the G20 Summit in Osaka

The G20 Summit in 2019 is being hosted by Japan in Osaka in the first year of "Reiwa", the new name of the era marking the reign of Japanese Emperor Naruhito who ascended the throne on May 1. "Reiwa" can be translated into English as "beautiful harmony". As this year's G20 host, Japan should work towards achieving such harmony not only at home but also around the world. It cannot, of course, do this alone. But in light of the decline in US leadership in global governance, in particular in the domain of international trade, the increasing struggle for hegemony in high technology between China and the US, and the spread of anti-globalization sentiment among voters in many countries, this summit is expected to play a pivotal role in restoring order in global governance to achieve economic prosperity and political security. In addition, long-term challenges such as widening income inequality, partly against the background of an aging society, as well as global environmental issues are overshadowing the merits of the Fourth Industrial Revolution, with its unprecedentedly widespread IT innovation. These issues are challenges for developed and developing nations equally, and thus the so-called Sustainable Development Goals (SDGs) are increasingly considered as crucial to realizing global welfare.

The issues that the G20 has to deal with from various perspectives are extremely complex, both domestically and internationally, and so the intellectual assistance of think-tanks worldwide is often required. We have the so-called T20 process prior to the G20 Summit itself in which experts from think-tanks in member nations scrutinize the issues and challenges to be discussed at

the summit and prioritize them for the G20 leaders.

For our May/June 2019 issue, we invited articles for our cover story mostly from authors who are directly involved in the T20 process or in international organizations such as the OECD, and thereby hope to showcase the priorities for the G20 Summit in Osaka.
